- 2. The Evolv Collection offers Evolv Rewards and all services provided through The Evolv Collections's App and the Evolv Rewards website for membership free of charge to registered account holders.
- 3. In addition to the above, when registering as a member our Privacy Policy and Cookie Policy apply and form part of these Terms. Details of which can be found here: www.evolvcollection.com/privacy-policy/, www.evolvcollection.com/cookies/.
- 4. Your access and use of the Evolv RewardsApp and/or the Evolv Rewards Site are subject to these Terms and by using them you agree to be bound by them. We may update and change the Evolv Rewards App and/or Evolv Rewards Site from time to time to reflect changes to Evolv Rewards services, our member's needs and/or business demands. We will try to give you reasonable notice of any material changes.

The Evolv Collection, Evolv Rewards - Terms of Use

1. Becoming a Member

- 1.1. To become a Member please go to the Evolv Rewards App (for Android™ or iPhone® device)/ Evolv Rewards Site and follow the prompts to create an account. You will be required to provide the following information:
- 1.1.1.first name and last name, email address, password and marketing preferences;
- 1.1.2.birthday (day, month, day) This information is required to receive any birthday rewards we may be offering and/ or for any alcohol purchases/ promotions.
- 1.2. Your membership will be automatically activated once you have successfully registered for an account with us. Your account details will then be available on our bookings and reservations system and we should have full access to your transactional history. Please note, it is your responsibility to ensure that any registration details that you provide are accurate and to establish that your account is active. You can check this by signing into the Evolv Rewards App or Evolv Rewards Site and raising a support ticket.
- 1.3. Any accounts which are not active shall not be entitled to any points, rewards and/or membership benefits. Furthermore, any potential points that you could have earned prior to your account being active will be forfeit.
- 1.4. By becoming a member you agree to:
- 1.4.1.not use the Evolv Rewards App or Evolve Rewards Site for unlawful purposes, including but not limited to sending or storing unlawful material or fraudulent purposes;
- 1.4.2.only use the Evolv Rewards App or Evolv Rewards Site for your sole, personal use and will not resell it to a third party;

- 1.4.3.not assign or otherwise transfer your account to any other person or legal entity;

2. Age Requirement

Membership is only available to persons aged 18 and over.

3. Membership, passwords and security

- 3.3. You are required to notify us of any and all changes to personal details. We will not be responsible for any loss of points resulting from you failing to notify us of any change in personal details (including contact details).

- 3.4. It is strictly prohibited for any one person to hold more than one membership account of Evolv Rewards. Your membership is non-transferable and may not be accessed by, sold to, combined with the membership of, or otherwise dealt with by, anyone else. We may immediately suspend or terminate your membership if we have reason to believe that you have breached any part of these Terms, including but not limited to:
- 3.4.1.holding multiple Memberships;
- 3.4.2. allowing any third party to access or use your Membership; and/or
- 3.4.3.providing inaccurate or fraudulent information in connection with the use of the Evolv Rewards App or Evolv Rewards SIte or otherwise in connection with your Membership.
- 3.5. If for whatever reason your Membership is terminated, then we may, without limitation:
- 3.5.1.cancel any pending, current or future points, rewards, promotional account credits and/ or any other related unredeemed vouchers that are associated with your Membership; and
- 3.5.2.reject or prevent you from joining The Evolv Collcetion's loyalty scheme 'Evolv Rewards' under a new account.
- 3.6. We reserve the right to suspend any account, at any time (at our discretion), if you have failed to comply with any of these Terms. In the case of misuse all Memberships of persons involved may be deleted along with any associated points and rewards, this may include a ban from visiting any restaurant operated by The Evolv Collection LTD.

4. Conditions of use

- 4.1.8.to launch an automated program or script, including, but not limited to, web spiders, web crawlers, web robots, web ants, web indexers, bots, viruses or worms, or any program which may make multiple server requests per second, or unduly burdens or hinders the operation and/or performance of the Evolv Rewards App or Evolv Rewards Site;

- 4.2. Furthermore, you agree not to access without authority, interfere with, damage or disrupt:
- 4.2.1.any part of the Evolv Rewards App or Evolv Rewards Site;
- 4.2.2.any equipment or network on which the Evolv Rewards App or Evolv Rewards Site is stored or hosted:
- 4.2.3.any software used in the provision of the Evolv Rewards App or Evolv Rewards Site:
- 4.2.4.any equipment, network or software owned or used by any third party.
- 4.3. By using the Evolv Rewards App or Evolv Rewards Site, you hereby acknowledge that whilst we do not have obligation to monitor your access to or use of the Evolv Rewards App or Evolv Rewards Site or review or edit any Member Generated Content, we will have the right to do so for the purpose of operating the Evolv Rewards App or Evolv Rewards Site to ensure compliance with these Terms and/or applicable law or as otherwise required by an order or requirement of a competent court or other judicial body.

5. Member Generated Content

- 5.1. The Evolv Rewards App or Evolv Rewards Site may at times allow you to submit, transmit, post or otherwise provide content including (but not limited to) reviews, comments, ratings, photos, images, text data, links and location information, send emails and other communications and submit suggestions, questions, ideas and other forms of information (Member Generated Content).

You wave the rights to any moral or other rights you may have in the Member Generated Content you submit in favour of us.
- 5.4. Whilst we do not control any material submitted to us under Member Generated Content we reserve the rights to edit, delete and modify any submission at any time without notice to you.

6. App Licence and Intellectual Property

- 6.1. Subject to these Terms, we grant you a personal, non-exclusive, non-transferable, revocable licence to enter and use the Evolv Rewards App and/or Evolv Rewards Site, solely to support your use of The Evolv Collection's loyalty scheme Evolv Rewards.
- 6.2. All intellectual property rights in or arising out of connection with the Evolv Rewards App and/or Evolv Rewards Site relating to The Evolv Collection's loyalty scheme Evolv Rewards shall at all times be owned by us (or our licensors). You will have no intellectual property rights in, or to the Evolv Rewards App and/or Evolv

Rewards Site or The Evolv Collection's loyalty scheme - Evolv Rewards other than the right to access and use under these Terms.

7. Links

Where the Evolv Rewards App and/or Evolv Rewards Site contains links to other sites and resources provided by third parties, these links are provided from your information only. Such links should not be interpreted as any kind of endorsement or approval by us of those linked websites or information you may obtain from them. We have no control over the contents of those sites or resources.

9. Governing Law

These Terms, and any dispute between you and us regarding these Terms, the Evolv Rewards App, Evolv Rewards Site or The Evolv Collection's loyalty scheme Evolv Rewards, shall be governed and dealt with by the laws of England. You and us both agree that the courts of England will have exclusive jurisdiction.

The Evolv Collection. Evolv Rewards - Terms of Service

1. Participating Restaurants

- 1.1. These Terms set out how you, as a Member, may accumulate points and rewards every time you visit one of our participating restaurants by using your membership at the time of your visit.
- 1.2. Participating restaurants include all The Evolv Collection's UK-established venues including South Place Hotel. (excludes any international The Evolv Collection sites outside of the UK (NYC, Queensyard, Qustavino's and Paris, Alcazar) and room rates within South Place Hotel)).

2. Membership Points

- 2.1. Your Membership is not a store card or credit card, it is the way in which we show our appreciation of your loyalty by rewarding you every time you visit a participating restaurant. Please note that any points you accumulate hold no monetary value and can not be exchanged for cash or credit.
- 2.2. We reserve the right at any time to adjust your points and rewards where we have reason to suspect you have breached these Terms or that fraudulent activity has occurred. As mentioned in the Terms of Use above you are liable for any unauthorised use of your membership.
- 2.3. Membership must be presented at the time of booking (for reservations) or at the time of requesting the bill (for walk-in and/or bar visits where advanced booking is not possible). Please note that the redemption or earning of points is not in conjunction with any other promotion, discount and/or offer including those that may be within your listed Membership rewards.

2.4. Points may:

- 2.4.1.take up to 24 hours to show up on your Membership profile after visiting a participating restaurant; and
- 2.4.2.only be earned on purchases of food and drink consumed within participating restaurants, up to a maximum of 2,500 points per transaction. Points will not be earnt on any non-food and drink items (e.g. and duties, taxes and or service charge(s) that may be payable).
- 2.4.3.be exchanged for rewards within the Evolv Rewards App and/or Evolv Rewards Site for Gift Cards and/or listed experiences.
- 2.4.4.be use a redeem rewards from your Membership (such as a Gift Card) to pay for all or part of your bill, you are only eligible for points addition on the updated sub-total.
- 2.4.5.be used to redeem rewards from your Membership such as Gift Cards and Experiences, once this transaction has taken place the points value of the Gift Card and/or Experience shall be deducted from your Membership points total. Except for special circumstances, we reserve the right to refuse to add points retrospectively to any Membership. If a Member wishes to request any points to be added then they must request this within 4 weeks of the date of the bill in question.
- 2.7. Points will expire after 12 months from earning. Once expired points are void and hold no value. Members may be contacted or Membership revoked if the Member

has been inactive (no bookings, visits, points earning or redemption) after a period of 36 months.

3. Evolv Rewards and Black Card Membership

- 3.1. There are two 'tiers' of Membership to The Evolv Collection's loyalty scheme Evolv Rewards, Evolv Reward Members and Black Card holding Members. All successful and active registrations to Evolv Rewards will be Evolv Reward members. Only eligible Evolv Reward members can become Black Card holders. - 3.2.Evolv Reward Members will receive one point for every £1.00 you spend at participating restaurants up to the value of £2,500.00 per visit.
